In consideration for the enrollment of my child(ren) at Toronto Islamic Academy (TIA);

1. I agree to pay, on the specified times, all tuition fees, dues, accounts, and other indebtedness incurred by the student.
2. TIA requires a withdrawal notice 3 months in advance by email no later than Nov 30th. After Nov 30th, any parent choosing to withdraw their child will be liable for the remainder of the school year's fees. During the 3 months' notice period, parents are required to pay applicable fees if any part of the notice period falls within the school year regardless of whether the child is attending the school or not. Parents that are on the 12-month payment plan will also be liable to pay the prorated fees. Once the withdrawal notice is received, the spot will be made available for other students to enroll. If a parent changes their mind, they may re-enroll their child by paying the registration fees. Enrollment will be based on the availability of space in the class. All fees paid are non-refundable.
3. In the case of temporary absence, withdrawal or removal from the school or any of its services, I am still obliged to pay all applicable fees.
4. I further understand that: a) If the tuition fee is outstanding for more than 15 days, the student will not be eligible to resume classes until the outstanding amount has been cleared; b) In the event that any school-related fees, textbooks, library books or any other material belonging to TIA are outstanding, report cards will not be issued until the outstanding account has been cleared.
5. I hereby grant permission for my child to be included in any pictures and/or videos connected with the school program and promotion of the school.
6. I hereby grant permission for my child to leave the school premises under the supervision of a staff member for neighborhood walks.
7. I hereby grant permission for my child to be included in academic assessments and competitions that the school chooses to participate in.
8. I hereby grant permission for my child to use all of the play equipment and to participate in all school activities.
9. I agree to assume all costs, responsibilities, liabilities and risks in connection with the child's enrollment as a student of Toronto Islamic Academy including, without limitation, the child's use of play and sports equipment, and participation in school activities.
10. I understand and agree that the school will not be responsible for anything that may happen as a result of false information given, or information withheld at the time of enrolment and any false information which may lead to my child's dismissal from the school.
11. I hereby grant permission for my child to use the internet for academic purposes at school.



12. I understand that a probation period of three months will be applied for all new students.

13. I hereby grant permission for my child to ride a school bus and leave the school premises under the supervision of a staff member to participate in school trips. I understand that if my child is not participating in a school trip, he/she must stay home. If the student is absent from the trip for any reason, the trip fee is non-refundable.

14. I acknowledge that I am aware of the programs in which my child will be participating in as a student of Toronto Islamic Academy and that all of my questions have been answered to my satisfaction.

15. I agree to follow the policies and procedures as stated in the Toronto Islamic Academy Parental Handbook.

16. I further release, remiss, and discharge TIA, its administrators, directors, staff and teachers and their respective heirs, executors, successors, and assigns, of and from all claims, demands, damages, actions or causes of action arising or to arise by reason of the child's participation in activities and programs at Toronto Islamic Academy.

17. I understand that the school and its staff are required to report suspected child abuse or neglect.

18. I understand that I must be respectful, courteous, and understanding towards all staff members at TIA. I also understand that if I, or anyone of my family members, is disrespectful by using non-courteous, insensitive, abusive, disrespectful language and/or behavior towards any staff member at TIA Elementary School, TIA reserves the right to dismiss my child(ren) from the school, and I am liable for the remainder of the school's tuition fee.
